PAIRINGS & HOLE ASSIGNMENTS:

CHECK IN:

9:00 - Shotgun at both courses.
Please check in 45 minutes prior to play.

PRIZE FUND:

You have the option of paying \$5.00 into the prize fund at each tournament. Please bring cash as we cannot accept checks for the prize fund.

CLOSEST TO THE HOLE:

SWGL will pay four places on each hole. Only list your name if your measurement is less than the ones listed on the recording sheet

PACE OF PLAY:

SWGL's goal again this year is to improve Pace of Play. You'll find helpful hints in your roster booklet, but the main one is to keep up with the group ahead of you. We have lots of ladies playing at the courses and need your help in making it a fun day for everyone.

CANCELLATION:
